I did work security for the High School Friday from about 8;30 or 9;00am until 1;10pm. I left Parker and went home and got my baby, she is 4 years old, to take her to Pace's Dewelery store in west Greenville to have her Ears Pierced. I got to West Greenville somewhere between 1;30pm and 2;00pm. When I got to West Greenvilde the traffic was heavelf and I could not turn around in the street so I went out Burdett at to Meson at and turned left headed backto Pendleton at. While I was sitting at the stop sign a J.P. Stevens truck bulled up behind me. I had to sit there for a few Min. to let the cars pass on Bendleton st before I could pull out headed bact to Pace's stome. While I was sitting there the Truck sitting behind me blew his horn twice wanting me to pull out. I noticed that a Colored male came out of the Parking lot of Looper's Garage and he started to go toward Easleys or the business section of West Greenville. He stoped and lookedboth ways then he ran toward the Gulf Station and Bi-Lo's. He was between 5'6" and 5'10", He weigh ed between 150 and 160 lbs, his hair was out over his ears. He was wearing a tan jacket and dark trousers. He was also wearing high soled shoes, I noticed them becouse of the way he started running. I watched him run to about the Ice Plant. I then pulled out onto Pendleton st and went to Pace's Jew. Store. I did not know then that anything was going on. I did not know until about 9,00pm that Mr Looper and Frank Looper had been shot. A friend of mine told me that they had been shot. Then Saturday Iwent I have read or had read to me, the above statement of \_\_\_\_\_ pages and it is true and correct as best I recall, and I have received a copy of this statement.
